NOTICE OF APPEAL

Notice is hereby given that Pittsburgh Glass Works, LLC (“PGW”), defendant in the above-named case, hereby appeals to the United States Court of Appeals for the Third Circuit from the following orders/judgments and all other connected or otherwise related orders:

1. The March 23, 2011, minute entry (Dkt. 68) and the March 24, 2011, order (Dkt. 69) denying PGW’s motion to dismiss Plaintiff Karlo’s retaliation claim;
2. The September 2, 2015, order (Dkt. 448) denying PGW’s motion for summary judgment on Plaintiff Karlo’s retaliation claim and denying PGW’s motion to strike unsupported facts and deem improperly contested facts admitted;
3. The January 6, 2016, order (Dkt. 537) denying PGW’s motions *in limine* and granting Plaintiff’s motions *in limine*;
4. The January 15, 2016, order (Dkt. 553) granting in part Plaintiff’s motion *in limine* to exclude expert testimony by Jeffrey Belack;
5. The January 21, 2016, order (Dkt. 564) denying PGW’s motion for judgment as a matter of law;

6. The January 22, 2016, order (Dkt. 573) entering final judgment in favor of Plaintiff Karlo and against PGW; and

7. The May 18, 2016, order (Dkt. 592) denying PGW's combined renewed motion for judgment as a matter of law, motion to alter or amend the judgment, and motion for a new trial.
