**JOINT MOTION TO AMEND THE SCHEDULING ORDER**

Counsel for Plaintiff, Equal Employment Opportunity Commission, (“EEOC”),  
Intervenor-Plaintiffs, Lee LaRaviere-Steele and Darrell Steele, and Defendants, Safelite Glass  
Corp. and Gregory Byrd, respectfully request the Court amend the Scheduling Order in the  
above-reference matter.

In support of this request, the parties state as follows:

1. Under the current Scheduling Order (Docket #8), the deadline for discovery is September 1, 2011 and the deadline for potentially dispositive motions is October 3, 2011.
2. The parties have diligently engaged in discovery of this case, including exchanging written discovery and scheduling depositions for material witnesses to this case.
3. On July 20, 2011 counsel met and conferred about the discovery and mediation of this case. At the meeting, the parties discussed the deposition schedule and the availability of a number of material witnesses. Counsel for all parties agreed that additional time for discovery is necessary in order to schedule depositions for all material witnesses to this case. In addition, the parties anticipate scheduling mediation on or about October 27, 2011.
4. Additionally, counsel agrees that an extension to the dispositive motions deadline to November 21, 2011 will enable the parties to engage in meaningful discussions at mediation to determine if resolution to this matter is possible.

WHEREFORE, the parties respectfully request that this Court find that there is good cause to grant the parties' motion for leave to amend the Scheduling Order and extend the discovery deadline to October 27, 2011 and the dispositive motions deadline to November 21, 2011. A proposed Order is attached to this Motion for the Court's convenience, pursuant to Local Rule 6.1.
